APPROVE MINUTES FOR REGULAR CALLED MEETING HELD ON FEBRUARY 27, 2017

Motion by/seconded, Commissioners Charlie Mattingly/Scott Moseley to approve the minutes for the regular called meeting held on February 27, 2017, as presented. Motion carried unanimously.

JULIE WAGNER-HARRODSBURG FIRST UPDATE ON SIDEWALK PROJECT

Julie Wagner with Harrodsburg First updated the Commission on the sidewalk project on Mooreland and Perryville Road. She announced that the engineering company has completed the first third of the design portion of the project. She also announced that she had spoken with Frankfort in regards to additional funding. The grant is an 80/20 match of which \$75,600.00 would be a cash match instead of in kind. The total grant would be \$302,400.00. The City would need to look at their budget to see if the cash match would be possible.

MAYOR LONG AUTHORIZED TO SIGN HAZARDOUS MITIGATION RESOLUTION

Motion by/seconded, Commissioners Scott Moseley/Jack Coleman to approve authorizing Mayor Eddie Long to sign the resolution accepting the hazardous mitigation plan to reduce disaster losses nationwide. Motion carried unanimously.

FIRST READING OF ORDINANCE 2017-05 ONE WAY STREET

First reading was given to Ordinance 2017-05 which will change the direction of travel to one way traffic on West Office street from U.S. 127 to Chiles Street. This will also create 19 parking spaces.

MAYOR LONG AUTHORIZED TO SIGN ORDER ESTABLISHING THE HOURS FOR SALT RIVER PARK

Motion by/seconded, Commissioners Charlie Mattingly/Scott Moseley to approve authorizing Mayor Long The Salt river Park shall have a gate erected at the entrance to the Park and a Sign posted stating that the park from May 1 to October 31 will be open to the public 7 am until 10 pm at which time the gate to the Park shall be locked until 7 am the next morning. The Park from November 1 to April 30 will be opened to the public beginning at 7am until 8pm at which time the gate to the park shall closed and locked until 7 am the next morning. Motion carried unanimously.
