MINUTES FOR REGULAR MEETING**

Mayor Eddie Long called the regular meeting to order. Members present, Mayor Eddie Long Commissioners; Jack Coleman, Scott Moseley and Charlie Mattingly. Absent: Bubby Isham.

**GEORGE CAMIC – NO PARKING ON MAIN STREET**

George Camic appeared before the Commission to complain about “no” parking on N. Main Street and the placement of the no parking signs. Commissioner Scott Moseley stated that he would look into the matter and get back with Mr. Camic.

**EXECUTIVE SESSION**

Motion by/seconded, Commissioners Scott Moseley/Charlie Mattingly to approve going into executive under the provisions of KRS 61.810 for the purposes of hiring personnel, at approximately 7:17 p.m. Motion carried.

**SECOND READING ON ORDINANCE 2017-13 AMBULANCE SERVICE CONTRACT**

Motion by/seconded, Mayor Eddie Long/Commissioner Jack Coleman to approve of giving second reading to the ambulance service contract containing no changes from the previous year. Motion carried unanimously.

**RAILROAD CROSSING CLOSURE ON EAST BROADWAY**

Amy Wickliffe with Norfolk Southern Railroad Company appeared before the Commission to answer questions and facilitate an agreement in regards to the closure of the railroad crossing on East Broadway due to safety concerns. They will entertain the idea of giving the City the opportunity to open another crossing if needed at a later date. They are offering the City a financial incentive and would pay for and be responsible for implementing the barricade for the closure.

West end of bypass(industry Rd) from Bohon intersection to Wausau Paper

Factory from 127 to Main Street both sides  
Harvest near intersection  
Oatfield near intersection  
Wheatfield near intersection
