**APPROVE MINUTES FOR REGULAR CALLED MEETING HELD ON OCTOBER 23, 2017**

Motion by/seconded, Commissioners Scott Moseley/Jack Coleman to approve the minutes for the regular called meeting held on October 23, 2017, as presented. Motion carried unanimously.

**APPROVE AND PAY OCTOBER INVOICES**

Motion by/seconded, Mayor Eddie Long/Commissioner Jack Coleman to approve and pay the October invoices which totaled \$75,239.03 for general fund, \$47,887.31 for water & sewer operating fund, \$11,770.00 for tourism development fund, for a total of \$134,896.34. Motion carried unanimously.

**CHRISTMAS PARADE ROUTE**

Motion by/seconded, Mayor Eddie Long/Scott Moseley to approve an alternate staging and route for the Christmas Parade using Broadway, Chiles, and Main Streets. Motion carried unanimously.

### **AMY EARLYWINE HIRED FULL-TIME**

Motion by/seconded, Commissioners Scott Mosley/Jack Coleman to approve moving Amy Earlywine from a part-time status to a full-time status at an hourly rate of \$11.48. Motion carried unanimously.

### **SECOND READING ON ORDINANCE 2017-22 ELM STREET**

### **MAYOR LONG AUTHORIZED TO SIGN RETENTION BASIN EASEMENT**

### **JIM REED HIRED**

Motion by/seconded, Commissioners Bubby Isham/Jack Coleman to approve hiring Jim Reed as a Wastewater Treatment Facilities Superintendent . The salary is still being negotiated. Motion carried unanimously.

### **OPEN AND AWARD THE BID FOR THE PROPERTY LOCATED AT 217 E. BROADWAY**

Motion by/seconded, Commissioners Bubby Isham/Scott Moseley to approve awarding the bid for the property located at 217 E. Broadway for \$505.00. The house is to be torn down after the right of rescission. Motion carried unanimously.
