**APPROVE MINUTES FOR REGULAR CALLED MEETING HELD ON FEBRUARY 12, 2018**

He stated that the contractor on the Water Distribution Project moved his meter and since then he claims that this caused his leak. He also wants the City to help him dig up the water line. The Commission agreed to get in touch with the contractor to see when they changed out the meter and to have the contractor look at the line to see if they caused his leak.
