**FIRST READING OF ORDINANCE 2018-01 BUDGET ORDINANCE**

First reading was given to Ordinance 2018-01 with appropriations as follows: The total proposed budget is \$14,781,347.66. The amount appropriated for General Fund is \$7,242,161.44. The amount appropriated for Water and Sewer Operating Fund is \$6,394,854.58. The amount appropriated for Municipal Aid Road Fund is \$538,238.77. The amount appropriated for Tourism Development Fund is \$365,035.00. The amount appropriated for Cemetery Trust Fund is \$72,057.87. The amount appropriated for the ABC Fund is 169,000.00.

**CENTRAL PAINTING AWARDED BID TO PAINT AT RAW WATER INTAKE BUILDING**
