APPROVE MINUTES FOR REGULAR CALLED MEETING HELD ON JUNE 26, 2018

Motion by/seconded, Commissioners Bubby Isham/Jack Coleman to approve the minutes for the regular called meeting held on June 26, 2018 as presented. Motion carried unanimously.

CRIMSON CLAYCOMB - KENDYL AND FRIENDS FOUNDATION

Motion by/seconded, Commissioners Scott Moseley/Jack Coleman to approve amending the budget so that the \$5,000.00 donation for Kendyl and Friends Foundation will come out of General Fund and the money that was going to come out of Tourism Funds will remain in the Tourism Fund and be moved to miscellaneous line item. Motion carried unanimously.

DANNY WOODS – RESTAURANT TAX

Danny Woods appeared before the Commission to ask them why the City of Harrodsburg has a restaurant tax and the City of Danville does not and to ask them to do away with the Restaurant Tax. He thinks that the citizens are already taxed too much. Mr. Woods was told that only 4th and 5th class cities can implement a restaurant tax and that Danville is a 3rd class city. They also stated that they couldn't do away with the tax without finding a way to fund Anderson Dean Park and the other tourist related organizations.
